## **Town Commission Meeting Minutes Monday, March 12, 2012 – 7:00 pm**

#### 1. Call to Order – (Keith Hughes)

Keith called the meeting to order at 7:16 p.m.

#### 2. Special Guests / Public Comments (limit of 2 – 3 minutes per person)

**Valerie White** brought the Commission a letter from the Art Festival Committee with details on dates (May 19 with a rain date of May 20), info on advertising. It will be the same as last year – closing street, rerouting DelDot bus, 55 vendor spots to rent at \$75 each, runs from 10 - 6. She stated the Bellefonte Art Shop has art classes, and they want to have art classes this summer for children. Wanted to know if they could rent out part of the day care for them. Commission told her that we now have two day cares interested in renting the space by this summer. Bob is doing a photo banner this year for the lamp posts. We gave Valerie last year's banners.

Kathy made a motion to approve \$350 donation to the Art Festival to sponsor a port-a-potty for which we would in turn receive a vendor space, name on t-shirt as a sponsor and advertising in the booklet - second by Ross. Motion carried unanimously.

**Rep. Debra Heffernan** – Our Representative brought a supply of important phone number cards for distribution. Holland Mulch has been open to the public for almost a year. Rep. Heffernan recently introduced legislation for free on line courses for active duty and National Guard members (that are not already receiving funding under the G.I. Bill). She has also introduced legislation for higher sentencing than burglary in the 1<sup>st</sup> degree for those found guilty of a home invasion. The definition of a home invasion is knowing someone is home or finds out someone is there and they stay and terrorize them. The bill introduced by Rep. Lawson is not as comprehensive. Debra has not only bi-partisan support but that of the Attorney General's office, also.

#### **John Cartier –** Mentioned numerous things this evening:

Do not throw drugs down drain. It winds up in our water sources.

Attended a meeting in March of NACO (3,000 counties) in D.C. He took a completely rail route to the meeting. The new Claymont commuter rail project would include platforms, pedestrian platforms, etc. He has lobbied DelDot and Septa about it. Newport is attempting to get a commuter rail stop.

New Castle County is 1 of the 2% of counties with a AAA bond rating. John is the co-chair of the finance committee. County Police lost binding arbitration which means County Administration prevailed. County Police have to give back 2.5% towards health care costs.

John announced the return of the ice cream festival at Rockwood in July. There would be a small admission fee to raise money for Friends of Rockwood.

Fox Point baseball league is moving towards a long term lease. They would maintain the facilities. (Side point – Town of Bellefonte is sponsoring a team again this year)

Carnival at St. Helena's – working with organizers and police so no problems at night. They will charge a small admission fee. It is April 29<sup>th</sup> – May 5<sup>th</sup>.

There is a high pressure gas main under Gov. Printz in area where sewer mains are being replaced. The County and contractor are at odds over backfill and support of the main causing delay.

There is going to be a ground breaking ceremony on March 28 from 10:30-11:30 for the Claymont Library on Darley Road and Philadelphia Pike. This will be a state of the art facility to be complete June 2013. There has been \$750,000 community fundraising and \$400,000 in grants. Delaware Brick doing a buy a brick program for \$150 each.

Kathy asked for the status of grandfathering of deed recording. John will check on this where people bought a house at Sheriff Sale and never recorded the deed.

#### 3. Minutes of Previous Meeting – reading and consideration for approval

Kathy made a motion to waive the reading of the minutes of the February 13, 2012 meeting and approve them as reviewed via e-mail. Seconded by Elaine. Motion carried unanimously.

#### 4. Building Inspector Report – (No one in attendance)

#### 5. Board of Adjustment Report - (Brian Donovan)

703 Highland – Since the variance was granted to divide the lot, it is a buildable lot. Elaine read Scott's e-mail regarding builder Glenn Prechtl's question into the record: Glenn,

Thanks for your email. The March 12th meeting is a Town Meeting of the Commissioners and is open to the public, so you are welcome to attend. The next meeting of the Planning Commission is on Thursday, March 22, at 7 pm, which is also open to the public.

The letter you seek is beyond the authority of either the Town Commission or the Planning Commission; according to our Land Use Code, the only person who can grant this approval is the Building Inspector, or by appeal, the Board of Adjustment. Since you have a letter of determination from our Board of Adjustment, this letter would state any conditions or restrictions to the subdivision. If none are stated, this means that the lot now meets the space requirements as buildable; however, the construction plan must still meet all the requirements of Land Use Code (setback, etc.) for a permit to be granted, which is the function of the Building Inspector, Kyle Bendler.

I hope this helps you, but if you would like to discuss this face to face, please attend either meeting stated above. I have copied Brian Donovan, chair of the Board of Adjustment, on this email, since he usually attends our Town Meetings.

Elaine read the bills (Attachment B). Motion to approve bills for payment by Kathy, second by Ross. Motion carried unanimously. Motion to amend the Electric bill for the school utilities to \$197.23 made by Elaine, second by Kathy.

- Day Care Rental There was much discussion around day care use/lease. We should ask for a letter of intent and a \$500 refundable deposit. We would give them a bill for electric usage because it is broken down into a separate meter. A reduced rate could be arranged for tenant. We should set up a meeting for both potential tenants to discuss their plans and requirements by the State.
