1. Call to Order (Keith Hughes)

President Hughes called the meeting to order at 7:03 p.m.

2. Special Guests / Public Comments (limit of 2 – 3 minutes per person)

Councilman Cartier said that County Executive Gordon's budget address would be Tuesday, March 19. He said that County property transfer tax receipts were running ahead of projections. He said that Elmer Setting is the new County Chief of Police and there will be a new plan and strategy for proactive and targeted policing, rather than reactive and call-driven as it is now. There will be a multi-agency coordinating meeting every Tuesday morning; he urged citizens to contact him with any concerns. Ross mentioned that we used to receive reports on police activity in the area. Mr. Cartier promised a comprehensive report (code enforcement, police, etc.) for our April meeting.

The Betz family, former proprietors, of Fat Rick's BBQ, brought food items to sample. Tina Betz made a presentation on a new trend of "pop-up" restaurants and food vendors and said that they thought Bellefonte would be a perfect locale for this. An establishment would use vacant lots, driveways, vacant buildings, etc. as temporary locations. Social media and other means would be used to publicize dates and places. This would theoretically be acceptable in the commercially-zoned area. The Betz's would have to work out arrangements with various property owners for their locations, and of course obtain the required State permits to serve food.

Kathy read the minutes of the February 11, 2013 meeting. Ross made a motion to approve the minutes as read; Kathy seconded. Motion carried.
