#### RESOLUTION NO. 15-052

#### CELEBRATING THE TOWN OF BELLEFONTE'S CENTENNIAL AS AN INCORPORATED TOWN

WHEREAS, the town of Bellefonte was granted incorporation by the Delaware State Legislators on the 9<sup>th</sup> day of March, 1915 and is celebrating its centennial on the 9<sup>th</sup> day of March, 2015; and

WHEREAS, Bellefonte was also known as Montrose fifteen years prior to the town being renamed to Bellefonte after its incorporation, consisting of sixteen houses and two general stores; and

WHEREAS, Bellefonte was a popular commuting stop for the people of the Brandywine Hundred area with the Darby cars that ran from Darby, Pennsylvania to Wilmington every hour. The fare was five cents for a round trip ticket; and

WHEREAS, in 1962, the Bellefonte Church United and the Hillcrest M.E. Church sold its property to the Town Commissioners for a Town Hall building; and

WHEREAS, on March 19, 1924, the Brandywine Hundred Fire Company No. 1 was organized and became the primary fire company for the area. Prior to the development of the new fire company, citizens gathered together to buy a few trucks and hoses and would volunteer to fight the many chimney and grass fires. One hundred people attended the organizing meeting and donated one dollar each to raise one hundred dollars towards their new fire company; and

WHEREAS, over the past one hundred years, Bellefonte continues to grow and change with the times. Starting with a population of two hundred and thirty seven in 1915 to one thousand one hundred seventy five in 2015 and growing.

NOW, THEREFORE, BE IT RESOLVED by and for the County Council of New Castle County that County Council hereby honors and congratulates the citizens of the Town of Bellefonte on its centennial.

## THE TOWN OF BELLEFONTE

As It Marks

THE CENTENNIAL OF ITS INCORPORATION ON THE NINTH DAY OF MARCH, 1915



HE SENATE JOINS THE CITIZENS OF BELLEFONTE in recognizing this important milestone in the town's history. First established as an unincorporated community known as Montrose, it was a collection of three sub-divisions, Montrose, Montrose Terrace and Montrose Terrace Addition. In 1910, the community consisted of 16 homes, two of which were located on farms and two more of which had small stores on the premises. The roads were dirt and most of the transportation was provided by horse-drawn conveyances of various types, with interurban trolley service,

known as the "Darby cars," between Darby, Pennsylvania, and Wilmington, which ran through the center of the town and stopped every hour. By January, 1915, the new town had grown to the point where the town commissioners applied to the Delaware General Assembly for an Act of Incorporation, which was duly enacted. The Act of Incorporation was signed by the town commissioners on the Ninth Day of March, 1915. The Senate honors the Town of Bellefonte and all its citizens, past and present, on this great occasion and extends the hope that Bellefonte will continue to thrive for many more years. The Senate directs that this tribute be presented to the Town of Bellefonte on this Ninth Day of March, 2015.

#### FROM THE SENATE RECORD

March 9, 2015

Mr. COONS: Mr. President, today I recognize the centennial anniversary for the town of Bellefonte, Delaware.

One hundred years ago, on March 9th, 1915, a small town located in New Castle County along the Delaware River gained its charter, and was incorporated by the Delaware State Legislature.

Previously known as Montrose, the tightly woven community was originally made up of sixteen homes. Residents of Bellefonte worked as farmers, as skilled laborers, and owned a handful of home-based businesses.

Bellefonte served, and continues to serve, the greater Delaware community by connecting Darby, Pennsylvania and Wilmington, Delaware.

As travelers entered the region by horse and wagon in the early 1900's, they would often leave belongings too large to carry onto the Darby cars with local shop owners. These items would later be delivered to patrons by horse and wagon, along with instrumental necessities, like milk, eggs, bread, coal, and ice.

By 1919, thanks to a collective community effort, the Bellefonte M.E. Church was built on the corner of Rosedale and Marion Avenues. That building would later be sold to the Town Commissioners and become the location of the Bellefonte Town Hall - a building that remains standing proudly today.

The community has withstood the test of time through the dedication of its citizens. From the fearless volunteers who fought fires in 1924 during the early days of the Brandywine Fire Company; to the stoic women who took the reins in the early 1940s when countless men went overseas to fight in World War II, community is the corner stone of this great American small town.

Today, Bellefonte lives on and flourishes with quaint vintage shops, comfortable cafés, and a farmers market that comes to life with an abundance of fresh produce every summer.

A historic town, a town rich with diverse ideas, Bellefonte has been critical to the fabric of Delaware, and remains an iconic landmark in New Castle County.

Although it has grown tremendously over the last one hundred years, Bellefonte maintains its small town feel and community principles, and will continue to instill those values in Delawareans of tomorrow.
