Town of Bellefonte, Delaware Town Meeting Minutes April 10, 2017

Attending: Dave Brenner, Brandon Dougherty, Andrew Ritchie and Treasurer Curt Nass

Excused: Ross Logan

Call to Order: Dave opened the meeting at 7:05

Scott made a motion to reorder the agenda to swear in Board of Elections members Ann Schneider and Pat Coward, seconded by Brandon, all in favor.

Dave swore them in using the Delaware State Oath of Office, and said that Rich Mulhern would be sworn in when he arrives.

Special Guests: NCC Councilman John Cartier attended and presented the Police/Crime Report, Property Maintenance Code Violation report, and a new report - Development - which shows all subdivision approvals and permits issues in the councilmatic district.

John is working on a new bank, WSFS, on the southern end of Philadelphia Pike near Bellefonte. They are looking for an available site. He also reported that NCC Council is working on a code change for brew pubs for commercial zoning, not industrial as it is now. This is why some new microbrews are located in industrial parks - if they don't serve food, that's where they have to be.

John also spoke about the opiod crisis, which seems to getting worse by the day. He mentioned that NCCPD and fire departments equipped with Narcan which reverse the effects of overdose, provided the heroin is not laced with anything else. We are at crisis level with deaths increasing from bad batches that contain other drugs to enhance the effect, like Fentanyl. John asked parents to educate their children and everyone about the very real dangers, call police and when needed, paramedics. Ann Schneider asked about the myth of prosecution for overdose. John said that the first priority is saving life, the second is law enforcement, and that being at a party where an overdose happens should not prevent anyone from calling for help. John also spoke about the proposed development of Brandywine Country Club and said that the future development is a long way from being presented to the County.

Meeting Minutes: Scott made a motion to waive the reading of the minutes to the previous meeting and approve them as distributed, seconded by Andrew Ritchie, and all voted in favor. The minutes will be posted on website.

Scott made a motion to delay the Planning Commission report, seconded by Brandon, and all were in favor.

Board of Adjustment: Brian Donovan said that we only have three current Board of Adjustment members. Need some new volunteers.

Building Inspector's Report: Scott reported on Code enforcement issues, saying that the process for Zoning approval had been worked out with the County and that the Zoning Review Board was having their first hearing tonight (concurrent to the Town Meeting)

Planning Commission Report – Carol Dougherty reported that the draft Comp Plan was almost ready to present and that Public Hearings were scheduled for the first Monday of May and June at 7 pm. Scott made a motion for up to \$200 to place a notice in News Journal, seconded by Dave and all were in favor.

Zoning Review Board – first application approved for roof replacement at 1008 Highland Avenue at the ZRB meeting on April 3. Second application was received Friday April 7 and the hearing is being held at this time.

Treasurer and Tax Collector's Report: Curt Nass presented the monthly Financial Reports for the Town (attached). Brandon made a motion to approve tax collector's report, Scott seconded and all in favor.

Board of Elections (cont'd): Dave swore in Rich Mulhern to the Board of Elections. Ann Schneider will send all applicable forms to the New Castle County Board of Elections.

Capital Improvement – Andy Moore said that Carmine Casper is making small revisions to the mechanical plans, and Andy has arranged for a structural engineer to review the plans before going to bid.

Road Paving - no activity or notification from DelDOT

Following a discussion, Scott made motion to endorse the idea of a Homeless Bill of Rights, Brandon seconded, and all were in favor.
