## Town of Bellefonte, Delaware Town Meeting Minutes January 14, 2019

#### Public Hearing for Ordinance 2018-01, 6 pm

**Attending:** Dave Brenner, Brandon Dougherty, and Scott MacKenzie. No members of the public attended. The hearing was called to order at 6:02 and closed at 7 pm. There were no comments.

#### Town Meeting, 7 pm

Attending: Dave Brenner, Brandon Dougherty, Scott MacKenzie, Andrew Ritchie, and Treasurer Curt Nass

Call to Order: Dave Brenner called the meeting to order at 7:02 pm.

**Special Guests/Public Comments:** NCC Councilman John Cartier said that he and his wife very much enjoyed the holiday party on Dec. 7 and John wishes everyone in Bellefonte a happy and healthy New Year. John presented the crime report for the month, with the most prominent complaint being car break-ins and larceny. John also presented the Property Maintenance Code enforcement report, stating that there were six open cases and that two are resolved. John reported on Highlights from his district: On January 21, the formal announcement will be made about the donation of the land of the current Claymont Steel site. The will allow development of the Claymont Transportation Center. All together with the Edgemoor Port facility, John said, Bellefonte is centrally poised to benefit from this redevelopment with regard to employment and economic development.

**Planning Commission Report** – Carol Dougherty said they had received feedback on the draft plan from the City of Wilmington and the State Office of Planning and were revising the Comp Plan. She reported that the ZRB had approved an application for 810 Brandywine Blvd.
