# Town of Bellefonte, Delaware Meeting Minutes October 14, 2019

### Public Hearing, 6 pm

Attending: Dave Brenner, Brandon Dougherty, Scott MacKenzie.

The Public Hearing was called to order at 6 pm by Dave Brenner. Copies of the Comp Plan were handed out to those attending, along with a FAQ prepared by Kathy McDonough. Attending from the Planning Commission were Kathy McDonough and Jim Paradise. There was no public comment. The Hearing was closed by Dave at 7 pm.

#### Town Meeting, 7 pm

Attending, Dave Brenner, Brandon Dougherty, Scott MacKenzie, and Treasurer Curt Nass. Excused: Andrew Ritchie

**Special Guests/Public Comment:** Sarah McBride introduced herself as candidate for Senatorial District 1, being vacated by Harris McDowell who is retiring. She gave a brief background and explained why she was running for office.

Elisa King of 904 Marion Avenue expressed some safety concern about traffic on Marion Avenue, (she lives on the corner of Melrose and Marion). She says that cars are going too fast and that they frequently run the stop sign at Euclid. She also said that there are frequently people walking up and down Marion and because there are no sidewalks, she is concerned for pedestrians and for children playing in the area. Scott will contact NCC police about enforcement. Scott will contact Deb Heffernan about speed indicator light (Sarah McBride emailed Deb Heffernan and requested the speed indicator light).

Minutes: Brandon made a motion to waive the reading of the minutes of the September 9 meeting and to approve them as distributed, seconded by Dave, and the vote was unanimous.

**Board of Adjustment:** Brian Donovan reported no activity.

**Planning Commission**: Jim Paradise reported that there have been no Zoning Review Board **applications in the past month**. Jim reached out to previous applicant for 410 Elizabeth. Pending affidavit from applicant to see if she was ready to refile. Jim said that the Planning Commission has started working on revising and updating the 2010 Land Use Code. They are also working to remove vagueness in some of the rules.

**Treasurer and Tax Collectors Report:** Curt Nass gave the Town's financial status as of September 30. Brandon motioned to approve, seconded by Dave and all approved.

**Public Comments:** Sarah McBride contacted Deb Heffernan about getting the speed indicator on Marion. Christine Sparks reported issue from Next Door about after hours use of the park. Scott said that park rules state that it closes at dusk, so if people are using it afterhours this is a police matter. Dave encouraged people to report these matters to the NCC Police for enforcement. Scott will arrange for the landscaper to empty trash and clean up any left items that were reported.

#### **New Business:**

- BHFC Auxiliary Donation to auction Scott motioned to approve \$250, seconded by Brandon, and all approved.
- Arden Concert Gild program Scott made a motion for renewal of ad for \$180 for 2019-20, seconded by Dave and approved by 2:1 vote (Dougherty, No).
- Reading of Ordinance: Scott made motion to read Ordinance 2019-01 in title only, seconded, and all approved. Dave read the ordinance in title alone: Scott made a motion to approve the reading as the first reading of ordinance, seconded by Brandon, all approved.
- 2018 Town Audit Report: Scott made a motion to approve the 2018 Audit Report, seconded by Dave and all approved. Scott also requested that Curt address the exceptions noted in the audit and to explain the deficiencies so that the residents understand the nature of the exceptions.
- Trash contract current trash contract expires January 15, 2020. Commission agreed to make public RFP. Scott made a motion to approve up to \$200 to issue RFP in News Journal, seconded by Dave and approved by all. Bids by 5 pm December 1.
- Snow plowing Contract does not include an increase. Same price as last year. Scott made a motion to approve the contract for annual snowplowing with Joseph Finocchiaro and Bros., seconded by Dave and all approved. Dave will sign and return contract to vendor.
