Call to Order: Dave Brenner called the meeting to order at 7:04 pm, welcome those attending and invited special guest John Cartier to present his update.

Special Guests/Public Comment: NCC Councilman John Cartier presented the police and property maintenance reports for the month. John announced that he has a new assistant, Michelle Rossi Gildea. He spoke about the ongoing development of the new Claymont Amtrak Train Station as well as the planning going forward for the former Evraz Steel Company site.

Board of Adjustment: BOA chair Brian Donovan reported no activity.

Planning Commission: PC chair Jim Paradise reported that there were no ZRB hearings during the past month. Jim said the Planning Commission is seeking approval of a contract for reviewed of Land Use Code. Scott made motion to approve the contract for review by the University of Delaware of our Land Use Code, for \$2,000, with \$1,000 approved for payment now, seconded by Brandon, and all in favor.
