Planning Commission Meeting, 6 pm

Town Commission Meeting, 7 pm

Call to Order: Dave Brenner called the meeting to order at 7:05 pm and welcomed those attending.

Public Comments: Daniel and Lori Nye of 1220 Brandywine Boulevard attended and asked questions about code enforcement by NCC Department of Land Use and how long it takes them to resolve a code enforcement issue. They were advised to be persistent and to keep filing complaints until the problem is resolved. They also asked for information about some planned renovations and were directed to look at the Town website, www.townofbellefonte.com and to look for information about the Zoning Review Board application.

Minutes to the Previous Meeting: Brandon made a motion to waive the reading and to approve the minutes as distributed, seconded by Andrew Ritchie, and approved by all.

Board of Adjustment: BOA Secretary Rich Mulhern reported no activity.

Planning Commission/ZRB: Member Steve Kimmel reported on the approval of ZRB application for 1010 Rosedale, and said that the Planning Commission continues to review the Land Use Code identifying gray areas in the code which might be expressed in a simpler way. He said they are also looking for areas of zoning code that are not covered in our Land Use ordinance.

Treasurer/Tax Collector's Report: Treasurer Curt Nass reported on the financial status of the Town as of December 31, 2019, and read the details of the monthly report (attached). Brandon motioned to accept the Treasurer and Tax Collector's Report, seconded by Andrew, and all approved.
