Call to Order: Dave called the meeting to order at 7:08

Minutes: Brandon made a motion to waive the reading of the minutes and to approve the minutes as distributed, seconded by Andrew and all approved.

Planning Commission Report: PC Chair Jim Paradise attended a Planning Workshop in Dover. He said it was very well attended and that he learned a lot. He said that the workshop had recommended Delaware City's signage code as being an ideal ordinance. Jim said he sent copies to all PC members for their review. He also wanted to discuss membership for the PC, which has five members, but one who has not attended meetings recently. - Commission Membership Scott motion to name Elisa King to fill the vacant commissioner chair expiring June 2021, seconded by Brandon and the vote was unanimous. Dave swore Elisa in using the State Oath of Office.
- Emergency Management Dave filled out meeting presentation request but has not heard back from them.

Public Comments: Brian Donovan reported that progress on 810 Brandywine Boulevard is being hung up not by NCC Department of Land Use but by DelDOT and the State Fire Marshal's Office.
