### Town of Bellefonte, Delaware Town Meeting and Public Hearing Minutes December 10, 2018

# Public Hearing for Ordinance 2018-01, 6-7 pm:

Attending: Dave Brenner, Brandon Dougherty, and Scott MacKenzie

Dave Brenner called the Public Hearing to order at 6:05 pm. A quorum of three Commissioners was met, but no residents attended. Scott gave a summary of legal advice regarding Ordinance 89-1 from Town Solicitor Seth Thompson, saying that New Castle County property maintenance code covered this topic and that Delaware Code already gave residents the right to take neighbors to court for drainage issues. His opinion was that we should repeal it. Being a zoning-related ordinance, the Town would hold two public hearings before voting.

Public Comments: None. The Public Hearing was closed at 7 pm, without objection.

### Town Meeting, 7 pm:

Attending: Dave Brenner, Brandon Dougherty, Scott MacKenzie, Andrew Ritchie, and Treasurer Curt Nass.

**Call to Order:** Dave Brenner called the Town Meeting to order at 7:04 pm.

**Special Guests/Public Comments:** John Cartier presented the monthly crime statistics report and the monthly code enforcement report; there are currently two unresolved code violations in town. John reported on ongoing code violations and delinquent taxes in the County, saying that both are a priority for the administration.

Dave asked for an update about Edgemoor Port renovations and John said that the County continues to pursue collaboration with State planners with the end goal of being able to review plans for the Edgemoor facility. John encouraged everyone to visit Rockwood Museum on Washington extension, which is decorated for the holidays – admission is free.

**Minutes to the Previous Meeting:** Brandon made a motion to waive the reading and to approve the draft minutes as previously distributed, seconded by Andrew and the motion was unanimously approved. Copies were passed out to those attending.

**Board of Adjustment:** Brian Donovan reported no activity. Scott suggested that Brian staff up the Board of Adjustment, sensing that there may soon be an application.

**Planning Commission:** Chair Carol Dougherty reported that there were no new approved building applications this month. She also reported happily that the current draft of the Comprehensive Plan has been sent to the State Office of Planning, the City of Wilmington, and to New Castle County.

**Treasurer and Tax Collector's Report:** Curt Nass presented the financial status for the Town as of November 30, 2018 (attached). Scott made a motion to approve, seconded by Brandon, and approved by all.

## **Correspondence:**

- Dave reported an email about maintenance of trees in right-of-way. The resident was informed that DelDOT is responsible for the right-of-way, but that any trees in the ROW were likely planted by former homeowners and the maintenance for said falls on the property owners.
- 1101 Monterrey call from new owners about trash receptacles. Referred to vendor.
- FOIA request regarding permits, etc. for1201 Brandywine Blvd. received 12/8. Scott will respond.

## **Capital Improvements:**

- Water heater new installed has been ordered.
- Dishwasher Dave reported that the dishwasher doesn't work and that getting an appliance repair person would probably cost more than replacement. The Commission agreed that there was no need to take action on the item at this time.

• Ceiling in Town Hall – Kathy will contact Andy Moore to see if he can make recommendations.

#### **Delinquent Taxes Update:**

• Scott reported that he had received an update from Town Solicitor Seth Thompson, who is actively working on monitions against residents who owed more than \$2,000 in back taxes.

**Holiday Party:** 100 attendees – great circulation between Town Hall and the Annex. The Commissioners agreed that it was a great success, but that there probably could have been more food, since it ran out early in the evening.

### **New Business:**

**Ordinance 2018-01**: Repealing Ordinance 89-1. Dave explained the rescinding of 89-1 Drainage. Scott made a motion to proceed with reading of Ordinance 89-1 in title only, without objection. Dave read the title of "Ordinance 2018 - An ordinance repealing Ordinance 89-1, Drainage, a zoning ordinance passed in 1990." Scott made a motion to approve first reading, seconded by Brandon, and all approved.
