Town of Bellefonte , Delaware Town Meeting Minutes

October 8, 2018

Attending: David Brenner, Brandon Dougherty, Scott MacKenzie, Andrew Ritchie, and Treasurer Curt Nass

Call to Order: Meeting was called to order by Dave Brenner at 7:15 pm.

Special Guests: NCC Councilman John Cartier said he no crime report or code enforcement report because the County was closed today for the holiday. He promised to send them later. John said he could now announce that, working with Sen. McDowell and Rep. Deb Heffernan, using State and NCC funding, a bark (dog) park will be installed at River Road Park in the coming year.

Rule to show cause against 1117 Brandywine Hundred, requiring code violations be addressed on the county will do the work and bill the property owners. Property owners did not appear at appeal hearing.

John said that the recently passed Craft Beer zoning categories has led to the creation of a soon-toopen craft brewery in Claymont at Town & Country Shopping Center.

John raised the issue of "trash districts" in New Castle County, which have been done in Kent and Sussex Counties for years. John also reported that he has a meeting with residents re: police response time along BB in Edgemoor Hills and Gordon Heights.

Minutes: Brandon made a motion to waive the reading and to approve them as distributed, seconded by Dave, and all approved.

Board of Adjustment: No activity to report; no one present.

Planning Commission Report: Tonight's meeting canceled lack of quorum, re-scheduled for 10/15. Zoning Review Application for 1016 Euclid Avenue was submitted, and had been conditionally approved pending actual application form. It is for solar panels.

No other applications have been received. There was an inquiry from a homeowner with a previous permit from 2016, the committee will review and approve the application, so he can get final inspection from the county.

The Planning Commission will meet on 10/16 at 7 pm, and will continue to work on the Comp Plan. The commission is currently trying to figure out how we can all see the document at one time for final edits.

Treasurer and Tax Collector's Report: Curt presented the Town's financial position as of September 30. Brandon made a motion to approve,, seconded by Dave, and all approved.

Presidents Report: Dave reported that there was an issue with a new trash receptacle, Monterrey and Prospect Avenue. Dave also reported a question about an outstanding open building permit, which was referred to the Planning Commission.

- Town Picnic The picnic was a success with an estimated 100 or more attending throughout the day.

- Drainage Ordinance Scott will contact Seth to see if he had a recommendation about this ordinance.
- Snowplowing Con Scott made a motion to renew the contract, seconded by Brandon. Discussion of specific pricing. All approved. Dave will sign and send to Fino.
- Donation to BHFC Brandon motioned to approve up to \$300 for gift certificates from businesses in town to be donated to the BHFC auction, seconded by Andrew and all approved.
- Holiday Party set for Friday December 7, 6:30 Charlotte Hash and Heavenly Hash are confirmed. Budget for event will be set at November meeting.
