## Town of Bellefonte, Delaware Town Meeting Minutes, June 8, 2020

**Attending:** David Brenner, Brandon Dougherty, Elisa King, Scott MacKenzie, Andrew Ritchie, and Treasurer Curt Nass.

**Call to Order:** The meeting was called to order by Dave Brenner at 7:07 pm and welcomed those attending.

**Minutes to the Previous Meeting:** Scott made a motion to waive the reading of the minutes and to approve them as distributed, seconded by Andrew Ritchie, and all were in favor.

**Board of Adjustment:** BOA Chair Brian Donovan reported no activity.

**Planning Commission:** There was no report as a meeting is being held right now. (Updated before end of meeting by Andrew Moore who reported that the PC did not have a quorum for a meeting).

**Treasurer and Tax Collector's Report:** Treasurer and Tax Collector Curt Nass presented the financial report for March, April, May combined. Brandon made a motion to accept the treasurer's and tax collector's report, seconded by Elisa, and all were in favor. (attached)

- No activity on capital improvements.
- Dave reported that the Town had received a request from the State office of planning for our Annual Questionnaire/Progress Report for our Comprehensive Plan. Scott and Dave will complete the form but ongoing this will be tasked to the Planning Commission in future.

#### **Old Business:**

Resolution 2020-01 - a resolution approving the 2021 Tax Rate and schedule of stipends. Scott made a motion to waive the reading of and to approve Resolution 2020-01, Andrew seconded the motion, and Dave called for discussion. There being none, all were in favor.

#### **New Business:**

- Change of Guard Dave announced that it was time to seat the new officers resulting from the election in June. The results as announced by the Board of Elections at the June meeting were that the number of positions exceeded those who registered for the election, canceling the election and declaring Brandon Dougherty re-elected, Dave elected as Treasurer, and Curt elected as Tax Collector. With that said, Dave turned over the chair to Scott and stepped down, as did Andrew Ritchie. Scott thanked Dave for his leadership and dedication over the past four years, which has left Bellefonte on a more stable financial position. Scott administered the Delaware oath of office to Brandon and he was seated, joining the Commission along with existing Commissioners King and MacKenzie.
- Scott nominated Andrew Ritchie as Commissioner, filling an empty seat with a term expiring in June 2022, seconded by Brandon, and the motion passed unanimously.
- Scott nominated Ross Logan as Commissioner filling an empty seat with a term expiring in June 2022, seconded by Elisa, and the motion passed unanimously.
- Scott nominated Andrew Ritchie as secretary for the coming year expiring June 2021, seconded by Elisa, and all were in favor.
- Andrew made a motion to nominate Scott as President of the Commission, seconded by Brandon, and passed unanimously.

• Scott asked if any of the Commissioners had any other new business. There being none, Scott read the bills for payment.
