Town of Bellefonte, Delaware Town Meeting Minutes, February 8, 2021

Call to Order: Scott MacKenzie called the meeting to order at 7:04 pm and welcomed those attending.

Minutes to the Previous Meeting: Brandon Dougherty made a motion to approve minutes of January 11, 2021, meeting and Andrew Ritchie seconded, all were in favor.

Special Guests and Public Comments: John Cartier, NCC Councilman attended meeting and presented community crime report and outlined major points of NCC property reassessment. The goal is to reassess to the true money value and to be revenue neutral. NCC will adjust the tax rate on the property value so in most cases property owners will pay what they pay now. On the county side, there will be no, or virtually no increases. This project will be completed two years down the road. It will keep level rates and institute a plan of rolling reassessment. The issue is fairness of the tax system. There are 210,000 properties in NCC.

Planning Commission: February meeting held on 2/8/2021. Comprehensive Plan was recommended for approval and is to be signed by governor. Two (2) ZRB applications approved on 1/25.

Treasurer's Report: Treasurer Dave Brenner presented the financial report for January (attached). Andrew Ritchie made the motion to accept the Treasurer's report, seconded by Scott MacKenzie seconded, all were in favor.

Tax Collector Report: Curt Nass presented Treasurer's report and reviewed delinquent tax report. Scott made a motion that all delinquent over \$1000 turned over to Seth for collections or monitions, Brandon Dougherty, all were in favor.

Scott MacKenzie made a motion to approve the tax collector's report, Elisa King seconded, all were in favor.
