### Town of Bellefonte, Delaware Town Meeting Minutes, July 12, 2021

**Public Comment:** Miroslaw Kostyshyn inquired about the most recent minutes on the website. Scott said the most recent minutes are up to date on website.

### Board of Adjustment: No report

**Planning Commission:** Jim Paradise, is resigning as Chair, Mark Fansler will be Chair and Kathy MacDonough., will be backup Chair and Secretary. Commission to receive updated land use code which was approved by Planning Commission at their last meeting. Town Commission will hold public hearings. Town Commission thanked Jim Paradise for his service to the Planning Commission and the Town.

**Treasurer's Report:** Treasurer Dave Brenner presented the financial report for June (attached). Elisa made the motion to accept the Treasurer's report, Brandon seconded, all were in favor. Scott made a motion to approve Barbacane Thornton as the Auditor for fiscal year 2021, Elisa seconded and all were in favor.

**Tax Collector Report:** Curt Nass presented Tax Collector's report and reviewed delinquent tax report. No changes in report.

- Capital Improvements Skirting completed around foundation of Town Hall steps and apron completed
- Stop Signs Stop signs installed at Marion and Melrose with new sign indicating new stop signs
- Historic marker Brandon contacted vendor for an update; no progress.
- Brandon made a motion to approve up to \$500.00 for Eagle Scout project to repair side steps on Town Hall, repair sign, re-install flag pole with lighting, Elisa seconded and all were in favor

# **New Business:**

**ARPA:** \$111,000 received; two public hearings held; American Recover Act Discussion. Scott presented some guidance for use of the funds and presented a plan for using the funds.

- The Town has until December 2025 to spend funds
- Scott suggested \$7,000 for residents to pay Bellefonte real estate taxes unpaid in 2020 (need to have paid in 2019)
- Scott suggested approximately \$1,000 each for a direct grant to small businesses
- Considering up to \$40,000 for an advertising program for Bellefonte businesses and rebuild consumer traffic
- Considering a beautification program for Brandywine Blvd and Philadelphia Pike
- ARPA Resolution 2021 Number 4, copies distributed and Scott made motion to read and approve in title only, Elisa seconded, and all were in favor. Scott made motion to approve, Elisa seconded, and all were in favor.

- ARPA Resolution 2021 Number 3, copies distributed and Scott made motion to read and approve in title only, Andrew seconded, and all were in favor. Scott made motion to approve, Elisa seconded and all were in favor.
- ARPA Resolution 2021 Number 2, copies distributed and Scott made motion to read and approve in title only and approve, Brandon seconded, and all were in favor. Scott made motion to approve, Elisa seconded
- AARPA Resolution 2021 Number 1, copies distributed and Scott made motion to read and approve in title only, Andrew seconded, and all were in favor. Scott made motion to approve, Elisa seconded, all were in favor.
- Curt has agreed to be Treasurer for AARPA program. Scott made a motion to make Curt ARPA Treasurer for the first year of the program for the fee of \$1,000, Elisa seconded, all were in favor. Curt Nass accepted the ARPA checkbook
