### Town of Bellefonte, Delaware Town Meeting Minutes, September 13, 2021

Call to Order: Scott MacKenzie called the meeting to order at 7:03 pm and welcomed those attending.

Minutes to the Previous Meeting: Elisa made a motion to approve minutes of August, 2021, meeting, seconded, all were in favor.

### Special Guests and Public Comments: John Cartier

Community Police Report given out. John discussed the Community Relief Act and how it could impact the community and how we could apply for funds. John discussed the Land Use projects going on in NCC including the Claymont Train Station. John discussed the most recent information related to COVID.

• Ethan Hann-Deschaine from the Boy Scouts was awarded an award for their work outside around Town Hall and the town flag pole.

Dave Farr, owner of the Bellefonte Cafe was curious about the town ARPA marketing campaign. He wanted to see at what stage this program was at.

Mike Lore, 706 Brandywine Boulevard, called about the house on the corner (810 Brandywine Boulevard) and the stilts. He wanted to know the status of what the plan is to fix it up. Scott spoke at length about what is going on in the town regarding zoning, parking, etc.

Board of Adjustment: Rich Mulher reported there was no activity.

**Planning Commission:** Scott gave the update on the Planning Commission. The land use code was sent to Seth Thompson. Kathy MacDonough updated that they had one application that they did not approve. They also want to schedule the public hearing for the October meeting and one in November. One year report on the Comprehensive Plan about filing a status update. She also wanted to update term updates for Jim and Frank.

- Bellefonte Day: Elisa brought us up to date on the status for October 2nd from 10am-3pm.
- Some discussion was brought up with who was going to provide the food. Sherm's has some scheduling conflicts so they could do it but they are severely short staffed and would need assistance from us to wrap burgers and hot dogs. Elisa discussed banners.
- ARPA-Hanging baskets/planters –Elisa was giving us an update about sprucing up the outside windows of the shops across from the Bellefonte Cafe. Scott felt it was a big expense to spend to dress up windows. Public discussion was allowed. Hanging basket and planters will be tabled.
- Elisa made a motion for up to \$3800.00 for beautification of windows on Mr. Chen's business. Ross seconded it. Motion was approved. All were in favor.

- Mural- Consideration of approving up to \$3000 for painting of mural on annex wall near playground. Scott made the motion and was seconded by Brandon. Some discussion about Clear-Coating it to make sure the paint will not be ruined. The motion was approved. All were in favor.
