Call to Order: The meeting was called to order at 7:06 pm

Minutes to the Previous Meeting: Scott made a motion to waive the reading of the April 11, 2022, meeting minutes and to approve as distributed; Elisa seconded, all were in favor.

Special Guests and Public Comment: John Cartier, NCC Councilman, attended and distributed the police community venue report. County completing the 30-year NCC comprehensive plan update (NCC 2050). Code enforcement will continue on 810 Brandywine Blvd. Councilman will assist with St. Helena's in planning next year's carnival event addressing safety factors.
