## Town of Bellefonte, Delaware Town Meeting Minutes, June 12 2023

**Absent:** Ross Logan

**Call to Order:** The meeting was called to order at 7:07 pm

**Minutes to the Previous Meeting**: Brandon made a motion to waive the reading of the May 8, 2023, meeting minutes and to approve them as distributed; Scott seconded, all were in favor with correction of the spelling of Dave Brenner's name. One edit to make, correct spelling of Dave Brenner.

**Special Guests and Public Comment**: NCC Councilman John Cartier could not attend because of a schedule conflict but sent Police and Property Maintenance Reports. No public comments were made.

**Board of Adjustments**: No activity.

**Planning Commission**: Report from Kathy McDonough. Permits approved for 1202 Brandywine for a deck and 957 Melrose for sheathing and new roof. New zoning map was approved.

**Annexation Committee:** Curt and Scott sent out letters to 22 properties notifying they are being annexed and giving them instructions on what they need to do and what they need to know. Five (5) confirmations of receipt have been received.

**Board of Elections**: Two candidates received, Curt Nass for Treasurer and Scott MacKenzie for Commissioner.

**Treasurer's Report**: Curt presented the Financial Report for May (attached) and a monthly progress budget report for Commission review. Transfer taxes received on two (2) properties. Andrew made a motion to accept the Treasurer's report as presented, Dave seconded, all were in favor.

ARPA: No changes.

Tax Collector's Report: Curt Nass provided tax collector's report. No changes.

#### **Old Business/President's Report/Correspondence:**

- Town property improvements; bid received for demolition and reconstruction of the stair lift, total is \$73,586. Will have additional expenditures for electrical and fire marshal requirements for the area.
- Sidewalks of Bellefonte Avenue out for bid by DelDOT.
- Security system update; new Ring camera purchased and will be installed to monitor Annex entrances.
- ARPA advertising/marketing contract; all commissioners sent update on progress from Elisa King
- Summer concert series; first concert postponed due to smoke, Brandon to let Scott know what the food or snack options will be for the shows so he can boost the events

**Public Comments:** None

Swearing in New Officers-selection of President and Secretary: Scott and Dave, whose terms ended today, stepped down from their seats. Andrew announced that the election was canceled because of lack of registration of candidates, Curt (Treasurer and Tax Collector) and Scott (Commissioner) did register and are now elected. Scott resumed his seat as Commissioner and nominated Andrew as Secretary, Brandon seconded, all were in favor. Andrew nominated Scott as President, Brandon seconded, all were in favor. Scott stated that there is now a vacant chair and called for nominations. Scott nominated Logan Ritchie to serve as Commissioner until June 2025, Brandon seconded, all were in favor. Logan was sworn in using the Delaware Oath of Office.

#### **New Business:**

- Scott requested approval for up to \$500 to reinstall welcome sign on Brandywine Blvd., Brandon seconded, all were in favor.
- Ordinance 2023-11; Adopting the Boundary and Zoning Map; Andrew made a motion to read in title only, Brandon seconded, all were in favor. Scott read the Ordinance in title only. Scott made a motion to proceed with second reading of Ordinance 2023-11 in title only, Brandon seconded, all were in favor. Scott made a motion to

- read Ordinance 2023-11 in title only and approve, Andrew seconded, all were in favor. Ordinance 2023-11 is adopted and becomes effective July 1, 2023.
- Scott made a motion to approve up to \$4000 in ARPA funds for beautification on Brandywine Boulevard, Scott will draft an application process for businesses, Curt will administer and Elisa will communicate, Andrew seconded, all were in favor.
